

VIC ROADS

After obtaining a Court Order apply to your local VicRoads office to get your licence or permit. You will get the same type of licence held previously (i.e. Learner permit, probationary or full). It is an offence to keep your licence or permit. The maximum penalty is \$520

#OFFENCES

(within 10 years of Licence Eligibility Hearing)

Previous offences includes: Drink and / or Drug Driving (inc. Interstate) offences, Manslaughter, Negligently cause serious injury, Culpable Driving, Dangerous Driving or Negligent Driving, Theft or Attempted Theft of m.v., "ANY" offence resulting in disqualification where finding regarding alcohol or both alcohol and drugs was made.

DRUG TESTING

Any driver in Victoria may be required to undertake a saliva test for the recent consumption of THC (Cannabis) and Methamphetamines (Speed) and Ecstasy.

INTERLOCK LICENCE CONDITION (ILC)

Breaches of the ILC can result in a fine of up to \$4500 or imprisonment for up to four months. Further, the Court may order the m.v. be immobilised up to 12 mths.

WRITTEN AND DRIVING TESTS

If you have not held a licence in the last **five years** you must pass a written & driving test.

DRIVING WHILE DISQUALIFIED

If you drive while disqualified the penalties are a fine of up to **\$4500** or jail for up to 4 months. For unlicensed driving a fine up to \$2600 or jail for up to 3 months.

CHOOSE A LEVEL BELOW

LEVEL 1 Drug Driving

- More than one offence # where the last offence was drug driving.
- Driving while impaired by a drug or refuse drug assessment.
- Refuse to provide blood / urine sample.
- Driving under the influence of drugs.
- Drug testing or refuse a drug test (Complete Step 2,3 & 5).

STEP 1 ⇒ Arrange for a first assessment with an Accredited Drug Agency. (First assessment must be completed min. 6 months prior to **Eligibility Hearing Date**. If the offence is Under the influence of drugs, an assessment must be completed min. 12 months prior.

(Magistrates may reduce time for assessments).

STEP 2 ⇒ Complete a Drug Driving Course.

STEP 3 ⇒ 28 days prior to cancellation ending go to Court closest to you and book for **Eligibility Hearing Date**. You will be contacted by the Police for an interview.

STEP 4 ⇒ Arrange for a 2nd assessment. A Licence Eligibility Report must be completed within 28 days of Hearing.

STEP 5 ⇒ Attend Hearing Date. Present the Court Order and Completion Certificate with ID to VicRoads.

LEVEL 2 Drink Driving

- First drink driving offence in the last ten years.
- BAC below 0.10%.

STEP 1 ⇒ Complete a Drink Driving Course. An Accredited drink driving education course helps you learn more about how alcohol and drugs affect your ability to drive, what your legal obligations are towards a compulsory alcohol Interlock program, what is a standard drink and how long to wait after drinking before it is safe to drive. The program helps minimise the high level of stress and anxiety associated with having an alcohol interlock fitted to a car and avoid the extra costs and delays in having an alcohol interlock condition automatically extended based on strict guidelines set by VicRoads.

STEP 2 ⇒ Present the Completion Certificate with ID to VicRoads.

STEP 3 ⇒ An application can be made to have an interlock removed under a Court managed interlock program. CALL Accredited Programs on (03) 9886 5099 to arrange for ILC removal order assessment.

LEVEL 3 Drink Driving

- More than one offence # with the most recent offence was drink driving.
- BAC 0.10% and above.
- Refusal or failing of breath test.
- Driving under the influence of Alcohol.

STEP 1 ⇒ Complete a Drink Driving Course.

STEP 2 ⇒ 28 days prior to cancellation ending go to Court closest to you and book for Eligibility Hearing Date. You will be contacted by Police for an interview.

STEP 3 ⇒ Arrange for first assessment. A Licence Eligibility Report must be completed within 28 days of Hearing.

STEP 4 ⇒ Attend Hearing Date. Present the Court Order and Completion Certificate with ID to VicRoads.

STEP 5 ⇒ 28 days prior to ILC ending go to Court closest to you and book for ILC removal order. You will be contacted by Police for an interview.

STEP 6 ⇒ CALL Accredited Programs on (03) 9886 5099 to arrange for ILC removal order assessment.

STEP 7 ⇒ Arrange for ILC report to be sent to Accredited Programs from the interlock supplier.

For drink driving offence committed from 01/10/14, go online or contact VicRoads to register for ALCOHOL INTERLOCK MANAGEMENT SYSTEM to be sent to Accredited Programs once the interlock licence condition has been completed.

ILC report must cover a period of at least 6 months.

STEP 8 ⇒ Attend ILC removal order hearing date. Present ILC removal order to VicRoads.

Alcohol Interlock Program managed by the courts.

ZERO BAC for three years will apply.
ILC must be issued.
